This amount, however, was not brought forward to the Grand Summary Table, which was, subsequently, not reflected in the Bid Submission Form. Only the amount in the Recurrent Cost Table was included in the Grand Summary Table. As a result, the Bid Submission Form only reflects the amount of the Recurrent Cost. After clarification from the Procurement Policy Office Helpdesk, it was clear that the onus lies on the bidder to make the correct entries. And as a procurement rule, bidder cannot be asked to modify the figures in the Bid Submission Form, except for arithmetical error, which is not the case. In view of the above, the bidder was not retained for further evaluation.
