- 9. **Best Evaluated Bid:** Network & Security Consulting Ltd, the lowest evaluated substantially responsive bid, for the contract amount of Rs 28,700,000.00 (exclusive of VAT) and excluding yearly maintenance charges.
- 10. **Negotiation:** Network & Security Consulting Ltd was called for a negotiation meeting as the price quoted was approximately 14.8% higher than the estimated cost. After negotiation, Network & Security Consulting Ltd proposed a 4% discount on the initial bid price of Rs 28,700,000.00 (exclusive of VAT). The final price after negotiation is Rs 27,552,000.00 (exclusive of VAT) and excluding yearly maintenance charges.
