This scheme was developed during the last quarter of 2020 through a series of consultations with various stakeholders of the public sector, including an innovation needs assessment of Ministries and Departments, to determine the most appropriate mode of operation.

A Call for Proposals was launched on the 1st of March 2021 with a deadline of 14th of May 2021. The MRIC received a total of 25 innovation collaborative proposals.

This project named 'Price Monitoring and Control Application (MOPRI)' is the second completed project under this scheme.

The first project was entitled 'An Artificial Intelligence (AI) Powered Trusted Due Diligence Platform with Integrated Dynamic Scoring Engine', was launched on the 2nd of February 2023.
